- 5. <u>Teri Shore:</u> SDC. Site still in State ownership. Developer chosen and has submitted a pre-application. Open space not yet transferred or protected. A Climate Center has been funded by grant to County.
 - a. <u>Legal: Janice Watkins:</u> Lead attorney Susan Brand Holly. Suit filed against County based on inadequate EIR study. Filed on 1-18-2023. County is preparing "Record" for court. Hearing date: 3-24-2024. Decision expected in May 2024. Traffic Report also considered invalid. Will be addressed in hearing. Need volunteers and financial support.

b. <u>100 Year Plan: Norm Gilroy:</u> recommends an Independent Special District be formed which would extend from Sonoma Mt to Arnold Drive and include all of Glen Ellen, Dunbar, Madrone and Diamond A. Formal application for same will be filed next week. Need help in getting 600 signatures for a petition as well as financial support. Scale of development should be that for a rural environment. 100 Year Plan was submitted to Board of Supervisors but ignored.
